

RETIRED CPL APPLICATION

I hereby apply for Retired CPL Certification in accordance with and under the terms of the Voluntary Certification Program as established by AAPL Policy and do hereby certify that: (i) I have read and understand and (ii) will comply with the current requirements for such Certification.

While I no longer will be required to maintain recertification credits or recertify every five (5) years, I understand that I must maintain my AAPL membership in good standing and that such dues will be reduced to one half the current yearly cost. I acknowledge that, while I shall enjoy all the privileges of an Active Member including the right to serve AAPL as a Committee member or its Chair, I shall be precluded from serving on AAPL's Executive Committee or its Board of Directors and that I can no longer sponsor RL, RPL, or CPL applicants.

I FURTHER UNDERSTAND THAT RETIRED CPLs SHALL BE PROHIBITED FROM PRACTICING LANDWORK FOR THIRD-PARTY COMPENSATION AND THAT SUCH STATUS MAY BE REVOKED AT THE DISCRETION OF THE CERTIFICATION COMMITTEE CHAIRMAN AND SUCH RETIRED CPL MAY BE REFERRED TO AAPL ETHICS COMMITTEE IF A RETIRED CPL RESUMES PRAC-TICING LANDWORK FOR THIRD-PARTY COMPENSATION IN THE CAPACITY AS A RETIRED CPL.

Change in certification status to Retired CPL shall be immediate upon approval by the Certification Chairman; however, its corresponding reduction of membership dues will take effect on applicant's next ensuing membership renewal date following approval. Regardless of when Retired CPL status is effective, AAPL will not refund any previously paid dues.

Any Retired CPL may reinstate their prior CPL status by: 1) written request to the Certification Committee and 2) either by passage of the current CPL exam pursuant to Article VIII of the AAPL Policy Manual, or by completing the CPL review class. The date of reinstatement shall be considered the start of a new five (5) year recertification period. Annual dues shall revert to full price on the next ensuing membership renewal date.

- Twice previously recertified my CPL designation; 3)
- 4) Retired from landwork and no longer perform landwork for third-party compensation
