As always, if you have any questions, concerns, suggestions or otherwise, please reach out to myself or any other Board member. Take care.

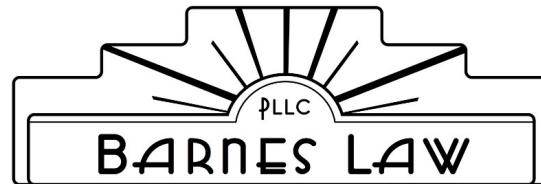

### ASK THE ATTORNEY

ASK THE ATTORNEY

Rather than answer a question this month, I wanted to bring to your attention a new precedent concerning multi-unit operations. In *Lawson v. Citizen Energy II*, 2021 OK CIV APP 1, the Court of Civil Appeals answered the question of whether, with respect to multi-unit wells, the commencement clause of a lease covering land in one section can be satisfied by the commencement of drilling operations in another section.

#### Facts of the Case

Harold Lawson entered an oil and gas lease (“Lawson Lease”) covering approximately 320 acres in the NW/4 and SE/4 of Section 11. The OCC spaced and pooled Sections 11 and 14 individually into 640-acre units. Subsequently, the OCC approved an application for a multi-unit horizontal well with a completion interval in both Section 11 and Section 14.

Citizen Energy II, as operator, commenced to drill a well, the *McWhirter 1H-14-11*, from a surface location in the SE/4 of Section 14, intending to drill a horizontal lateral that would eventually penetrate Section 11. The lateral did not penetrate Section 11 unit until **after** the expiration of the Lawson Lease’s primary term. However, commencement of operations for the drilling of the *McWhirter* well occurred on the Section 14 unit **before** the expiration of the Lawson Lease. The parties disputed whether the operations in the Section 14 unit satisfied the commencement of drilling clause in the Lawson Lease.

#### ANALYSIS

On appeal, the Court of Civil Appeals affirmed the lower court’s decision, and held that an operator’s commencement of horizontal drilling activities in one unit should be treated as commencement activities in other units affected by the same well.

In its holding, the court focused on the 2011 Shale Reservoir Development Act (“the Act”), which authorizes the Corporation Commission to regulate horizontal drilling in Oklahoma. Significantly, the statute provides that “a multiunit horizontal well shall be treated as a well in each of the *affected* units and shall be subject to all of the rules otherwise applicable to any other well in any of the *affected* units.” 52 O.S. § 87.8(B)(3) (emphasis added). The court determined that this language was unambiguous, and that application of §87.8 must include the anticipated location of the proposed multi-unit horizontal well to be drilled in each affected unit. In its conclusion, the court stated that Sections 11 and 14 were affected units under the Act, and therefore a multi-unit horizontal well drilled in the Section 14 unit is treated as a well in Section 11. Thus, the commencement of operations in the Section 14 unit during the Lawson Lease’s primary term extended the Lease as a matter of law.

While this decision is a major win for Oklahoma oil and gas stakeholders and has major implications for multi-unit operators in Oklahoma, it does not guarantee the same outcome for every situation. Any analysis of “commencement of operations” will necessarily be based upon the specific provisions of the subject oil and gas lease. So make sure you are cognizant of your leases’ provisions, and aware of the repercussions that the *Lawson* decision may have on those provisions.

And for all my juris doctorate landmen asking how a Court of Civil Appeals decision is precedential, the Oklahoma Supreme Court specifically approved the *Lawson* decision for publication, making it binding precedential authority.

## AAPL DIRECTOR'S REPORT

The AAPL Quarterly Board Meeting was a hybrid meeting in which some parties participated virtually, and others attended in person at the Omni Hotel in Fort Worth, Texas. The following notes are only a portion of the meeting. Should any member like to discuss more in detail, then please feel free reach out to me.

### **AAPL By The Numbers – Membership is overall down about 20% from this time last year.**

- 12,152 AAPL members (as of 12/31/20 – compared to 15,101 same time last year)
- 5,001 CPL's, RPL's, and RL's (as of January 2020 – compared to 5,328 same time last year)

### **Education**

- FREE monthly AAPL seminars are on Thursday's. Be on the lookout!
- Stacey Gavin's employment with AAPL ended February 3, 2021. Joanne Stoy was promoted to Certification Manager and Linda Stover was promoted to Manager of Education & Member Services.
- **Recertification Extensions:**
  - RL's – Certification Committee authorized a 90-day extension with certification expiration dates of 3/31/20 – 12/31/20 to earn required recertification credits.
  - RPL's & CPL's – there is already a 90 day "grace period" to meet recertification requirements; however, the Certification Committee has authorized a 90 day extension (total 180 days) with certification dates of 3/31/20 – 12/31/20.

### **Financials**

The March Board meeting normally yields a vote on the next year's budget, however, the board focused on what we could do to cut the budget expenses. The AAPL was expecting a significantly loss this year (~\$3 million); but, the AAPL investment accounts (although unrealized) outperformed our expectations and covered the losses for this year. Many of the board members (including myself) supported not to cut benefits to the membership at this time, however, the actual budget vote will be coming soon. The thought centers around the belief that these difficult times are the reason the AAPL has the money that it does. The savings and investing should help us weather this challenging time. I will be trying to make sure no cuts are made regarding benefits to the members. The following are accounts associated with the AAPL and the dollar amounts as of 12/31/20:

- Total Assets = \$42,753,477 (up from \$39,140,986 as of 12/31/19)
- AAPL, Inc's Investment Accounts = \$36,280,153 (up from \$31,831,731 as of 12/31/19)
- AAPL Educational Foundation, Inc. = **\$5,114,225** (up from \$4,560,188 as of 12/31/19)
- Landman Scholarship Trust = \$9,114,016 (up from \$8,088,283 as of 12/31/19)

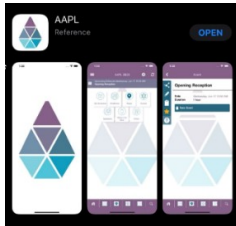

## AAPL DIRECTOR'S REPORT

### Committee and Other Items to Note

- AAPL's Forms Committee lead by Larry Coshow continues to do great work! Go to the website to find many **FREE** forms (for members) approved by the AAPL!
- In 2017, the AAPL Board of Directors approved a dues increase from \$100 to \$125 **AND** an automatic increase in dues to \$150 effective July 1, 2020. One year ago, the AAPL Board of Directors approved delaying the increase until July 1, 2021 due to the current environment. At this meeting, the AAPL Board of Directors again approved delaying the increase due to the current environment. The automatic increase will go into effect July 1, 2022 (unless next year's Board defers again).
- AAPL staff upgraded its software Personify – recently went live (March 18)!
- **RESULTS** of Membership Satisfaction Survey:
  - ◇ Survey successfully delivered to 11,010 members – 310 members responded.
  - ◇ 40% of respondents had more than 20 years' experience; 20% had 11-15 years; and 24% had 6-10 years' experience.
  - ◇ 65% said that the value of membership was good to very good.
  - ◇ 88% agree that being an AAPL member enhances credibility within the land profession community.
  - ◇ Education, Membership Directory, Landman Magazine articles and Networking events were the top four benefits of being a member.

- **CONTRACT CENTER: Keep an eye out for this!** More and more documents/contracts are being made available through the AAPL website and downloadable from Contract Center. A second round of forms has been approved and funded for preparation – NPRI Ratification and Pooling. Production Sharing Agreements, Participation Agreements, and Purchase and Sale Agreements are in the works! *Membership has its benefits!*
- **Professional Development Assistance:** Did you know? AAPL will provide up to \$300 per educational event, twice a year per member in reimbursement. There is no "need" base requirement for the reimbursement and any active member in good standing can apply.
- New language regarding the definition of Landwork was introduced. After the new verbiage passed last year, many members voiced concerned. The Board of Directors passed a new version and will be voted on by membership at the June Annual Meeting. The intent is to include those members that work in other aspects of the energy world outside of oil and natural gas.

Next board meeting will be at Live! by Lowes in Arlington, Texas – June 22-23, 2021.

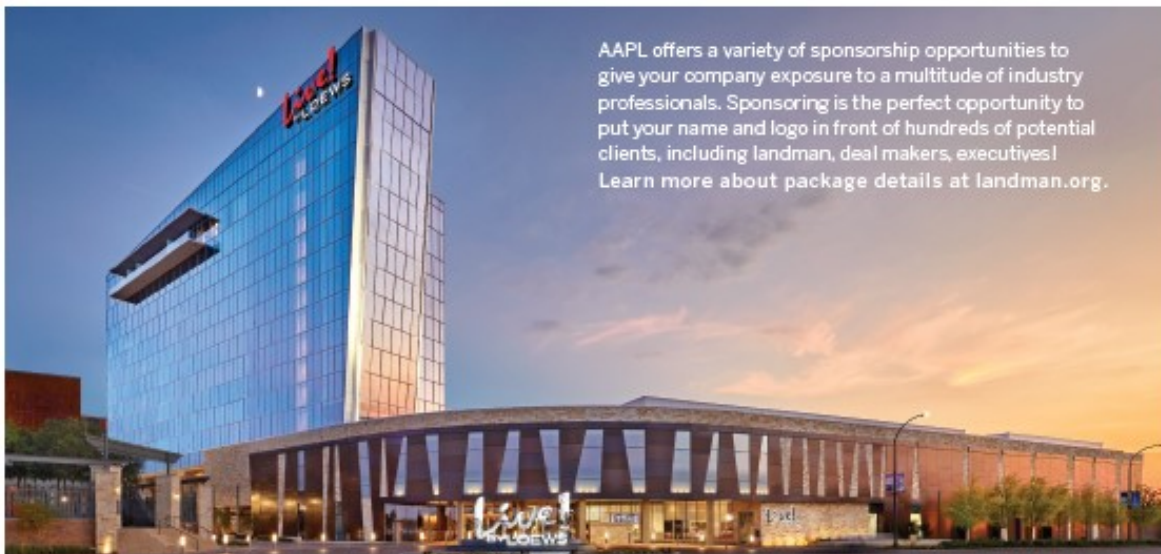

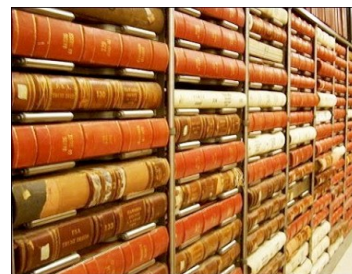
