Jeff Myers, CPL is currently semi-retired as an Oil and Gas Executive and Owner of Landmen.com, Inc. He is a 1979 graduate of the University of Oklahoma with a major in Petroleum Land Management, where he was awarded the Julian J. Rothbaum Award, which is given to the highest-ranking graduating senior in the PLM program. Jeff has been a successful business owner and Landman for over 30 years.

One of Mr. Myers' most celebrated career accomplishments has been the founding of Associated Resources Inc. in 1993, which specializes in the outsourcing of various oil and gas contractors for services covering all aspects of the Energy field.
