- Slide 1: Welcome to DAPL Presidents' Night.

We have a lot to cover this evening so I'm going to dig right in.

We're here tonight for the two reasons, to celebrate the leadership from Presidents of both DAPL and AAPL and earn some Continuing Education Credits. I'm very excited about our education event tonight. We have an awesome panel on Leadership in Energy.

- Slide 2: Announce special guests

As we all know, DAPL was founded in 1952. I would be remiss if I did not mention that in our 71-year history, we've had 71 Presidents including two leaders complete two different terms as President. Frank McColloch was our 39th President and 58th President, while Brooks Yates was our 40th and 57th President.

Thank you, gentlemen, for your Leadership of DAPL. Sitting with Brooks and Frank tonight we have a 7 past DAPL Presidents that combine for a total of 9 DAPL Presidential terms. Welcome Kelly Kessler, Brian Tolson, Iris Bradley, Heath Burnett, and Alicia Surrat. I also want to welcome to Ann Hallam, Josh Raley any other former DAPL Presidents that I missed, I know we have quite a few here with us.

- Slide 3: Gray Reed

Tonight, would not be possible without our Title Sponsor Gray Reed. With practices covering everything from Blockchain and Digital Assets to Construction, from Energy to Labor & Employment and from Private Equity to Transaction – they do it all. Thank you to Charlie Sartain for your firm’s generosity and commitment to DAPL.

- Slide 4: Corporate Sponsorships

Last spring the DAPL voted to align our operating year and fiscal year in addition to some other bylaws changes. Those changes required the DAPL board to either conduct a mid-year dues collection or attempt to stretch the budget for 18 months. The latter was chosen and to bridge the budget gap and try to streamline the advertising and sponsorship roles, we created the DAPL Corporate Sponsorship Program. This program and associated revenue has helped us bridge the expected budget shortfall this term. The program provides companies and individuals with a way to pay a single charge for a full year of advertising and sponsorships with DAPL.

Some of the benefits include Being a table sponsor for certain events, being named a presenting sponsor for a DAPL luncheon, dinner or even the Christmas Party, including your company logo on the DAPL Team shirts for the fall and spring philanthropies, the Susan G. Komen Race for the Cure and the Special Olympics State Track meet.

If you would like to become a sponsor for next year, please reach out to Foster Green for more information. Sponsorships packages start at \$1500.

Implementing this new program allowed us to not only protect the meetings and philanthropy events that the DAPL is well known for, but it ultimately allowed us to end the fiscal year with a surplus. It’s a small surplus, but your DAPL worked hard to reduce costs, put on fantastic events and pinch pennies. Thank you to the DAPL board of directors this year for your hard work.

- Slide 5: 2023-2024 Approved Budget

This leads us to our budget, schedule, and board for next year. Our Treasurer, Mason Guinn, Second Vice President Golf – Patrick Durman, Third Vice President Clay Shoot - Hagen Vasek, Social Director – Ryan Harkins and Education Director – Nathan Eubanks worked their tails off to ensure next year we don't have a deficit in our budget and our events and services are even better than this year. The budget and schedule were approved at our board meeting last Monday. Tonight, I'll provide just a few highlights:

- This is a balanced budget totaling \$276,500 – one of the largest in the history of DAPL.
- The budget includes expected grants of more than \$50,000 to our favorite Dallas charities including, Texas Scottish Rite Hospital for Children, Treasured Vessels Foundation, Susan G. Komen, and Special Olympics Texas.
- The Dallas Petroleum Club provides complimentary meeting rooms to the DAPL Board and most of the board meetings will occur at the Petroleum Club for no charge and no or very minimal impact on our budget
- DAPL is proud to be only 1 of 3 local associations in Texas to help HAPL pay for a lobbyist to protect and further the Texas Landman profession.
- DAPL is maintaining our Membership Certification Reimbursement Program – one of only two local associations to have a similar program.
- The DAPL Golf Tournament is contributing \$5,000 in DAPL Scholarships to students at AAPL Accredited Programs
- The DAPL Clay Shoot is contributing more than \$18,000 to the DAPL general operating fund in addition to making a record donation to a charity partner.

- Slide 6 Approved Budget Revenue vs. Expenditures

As I mentioned the DAPL Board worked many hours to balance and finalize this budget. This is a brief glimpse into the expected expenses and revenue. A few notes:

- As you can see Membership fees account for only 12% of our revenue, but we plan to spend 25% of our annual budget on membership meetings and benefits.
- Our Golf and Clay Shoot sponsors and players help us hold more membership meetings and provide more benefits, like the Membership Certification Reimbursement Program.
- The Corporate Sponsorship Program accounts for about 11% of our revenue for next year – sign up today!

- Slide 7: 2023-2024 Schedule

We could not have created the budget without setting the schedule. As you can see next year's schedule looks very similar to this year – we did not drastically cut back on our meetings or benefits to balance the budget. We have more than 20 events for our members next year. We have scheduled 7 board meetings; the bylaws require 6 and we have scheduled 8 member meetings and the bylaws require 5. As we begin to reach out to venues and put deposits down and confirm dates, the DAPL website will post these and open registration for our members.

- Slide 8: Proposed DAPL Board of Directors

I am very excited to highlight the board for next year, it is arguably the strongest DAPL board of directors ever. The DAPL ballot was sent out last Thursday and is due back to the DAPL Secretary by May 15. Your board next year had very little turnover, only three new directors are required, with one of those on the board this year in Kelly Kessler, DAPL Secretary.

I've highlighted some points over on the right side, but it's worth reiterating:

- The board for next year has the most DAPL board experience of any board in our 71 year history and has a great mix of veteran and new Landmen.
- The new board has 6 women, the most of any local association that I could find.
- 81% of the new board maintains an AAPL certification, the most of any local association that I could find.
- And my two favorite statistics tie the DAPL and AAPL together
 - We have 3 DAPL board members on the current or next year AAPL Executive Committee and DAPL and its members have won 4 AAPL awards in the past 12 months.
 - 2022 Directors Communication – Brian Tolson
 - 2023 Member Communication
 - 2023 Horizon Award – Iris Bradley
 - 2023 Largest AAPL Growth - DAPL

- Slide 9: Sara Williams Memorial Scholarship Update

The DAPL has an incredible history of giving back to our community and taking care of our own. In 2008 the DAPL helped friends and family of Dallas Landman Sara Williams endow a scholarship in her memory. The scholarship was originally created after donating more than \$40,000. The current balance of the endowment is nearly \$90,000. The scholarship grants at least \$2,000, annually to a female Junior or Senior energy management student who excels in academics, leadership, community service and who best demonstrates the professionalism abilities and spirit that Sara Williams so exhibited.

Sara Williams, a Yukon, Okla., native and longtime Dallas-based landman, died of leukemia Oct. 8, 2007, at the young age of 51. To honor her memory in 2008 her friends and colleagues started working to establish the Sara Williams Memorial Scholarship to be awarded annually to a Price College Energy Management student. The idea for the Sara Williams Memorial Scholarship came from a January 2008 AAPL NAPE lunch meeting when 12 female landmen were exploring ideas on how to honor Williams' memory and celebrate her life. They decided to raise money for an endowed scholarship at the University of Oklahoma, with the intended recipient to be a female energy management student. The first three donations totaling \$2,225 were received on Feb. 20, 2008, and more than \$54,000 had been raised by NAPE 2009.

"We wanted to do something that would keep on giving and would encourage other young people, especially women, to go into this business," says Leslie Wylie, senior vice president and general counsel at Trek Resources and one of the scholarship organizers. "Sara is a great role model for them." Wylie first met Williams in the early 1990s at Pacific Enterprises, an oil and gas exploration company in Dallas. "Sara was very personable, ethical, driven and respected in the business," Wylie remembers.

Her dearest friends and DAPL members on the committee said at the time of the first award in 2009:

"Sara Williams... was a daughter, a mother, a sister, a best friend, an athlete, a colleague, an Oklahoman and a landman. As a landman is how most people came to meet and know her, but it was the other titles that made us love her. Her beauty and winning smile were the first attributes that most people noticed, but after getting to know Sara, her inner beauty was what shined the brightest."

"Sara had grit and fought every minute of every day to live, this award and scholarship is about overcoming obstacles, Sara's spirit of life and helping the next generation of female landmen."

Congratulations to the 14 incredible young women that have won this scholarship and help us remember Sara each year.

I was on the DAPL board of directors when these funds were being raised and DAPL was one of the first donations given and I'm proud, as should you, to be a member of DAPL and have been a small part in this journey.

It is time to announce our DAPL Landman of the year!

Our 2023 DAPL Landman of the Year Award Winner is Nancy McCaskell

Nancy is a career Land Professional, providing expert analysis, decision making skills and management style matched by few. Her professionalism, ability to mentor young Land Professionals and constant reach for the highest AAPL ethical standards are what make her our Landman of the Year.

During one industry downturn she used her skills to teach high school English. This love of teaching and being a mentor has not only helped nurture many young Land Professionals, but her guidance and friendship have helped many young people to break into the industry and climb the corporate ladder. She has literally guided Landmen to the c-suite. She is an incredible ambassador for our profession, industry, DAPL and AAPL.

She is always at the forefront of new management styles as a dedicated reader of the Harvard Business Review and regularly has discussions concerning the latest trends and research regarding human resources. This not only helps her manage effectively but helps her give solid advice to up and coming Land Professionals. Her insight into being a successful female Land Professional, a Landmam as she loves to call it, in a predominately male industry is extremely helpful to young female Land Professionals. She has likely unofficially mentored hundreds of Land Professionals and her positive impact on the industry and especially our profession is very well-known and widespread.

She has chaired some of the most important committees for AAPL including Accreditation and Ethics and has participated on most AAPL committees, including a previous executive committee appointment in 2021-2022. She also led the Landman Scholarship Trust during a global pandemic. Her leadership style, while being distinctly Nancy, is also reflective of her mantra of “be kind”. Leaders make hard decisions, but she makes tough decisions and delivers news with compassion and empathy. She was recently nominated for AAPL 1st Vice President. Her keynote address in Chicago at the 68th annual AAPL Meeting Horizon Breakfast was inspirational while also providing an insight into her greatest career challenge, overcoming failure, and learning to lead.

Our 2023 DAPL Lifetime Achievement Award Winner is Jay Beavers.

Jay began his career with Placid Oil Co. after graduating from Texas A&M University in 1977, he jokes often about his infallible “Aggie Math” he learned there. He joined the Mississippi Association of Petroleum Landmen and the AAPL in January 1978.

While living in Jackson, Mississippi, Jay met Julia – the best thing to ever happen to him. In 1980 they moved to his family’s ranch near Sanger, Texas, where they raised their two sons, James and Travis, who have joined us here tonight.

A Certified Professional Landman, Jay worked as a company landman for Enserch Exploration Inc. in Dallas for 12 years and for UPRC in Fort Worth for eight years until Anadarko Petroleum Corp. acquired UPRC.

Since 2000, Beavers has been working as an independent landman at his office located next door to the Dairy Queen in Sanger. His commitment to the AAPL has been demonstrated by serving on many AAPL committees, chairing the AAPL Certification Committee, the AAPL Awards Committee, the Nomination Committee and the Southwestern Legal Foundation Landman’s Institute as well as serving as AAPL treasurer, first vice president, AAPL President in 2019-2020.

Jay is my friend and has positively impacted my career like he has done to so many others. Whether he was talking to me about running title, hard negotiations, AAPL committee assignments or really important matters like his favorite Dallas Cowboy tight-end – Jay Novacek, he is always in the present and willing sit, talk or listen. I had the honor and privilege to work with Jay on the AAPL Executive Committee a few years ago, his sheer love for AAPL has no bounds. I also learned the phrase – “High tech, low tech and no tech” in reference to anything digital.

Jay and Julia have opened their doors, mentored, and impacted so many landmen. They regularly host friends and family on their family ranch in Sanger – if you ever get invited, I highly recommend going as they have a zip line, ponies for little ones and real dinosaur bones. They have two wonderful sons that have followed in their fathers’ footsteps and are making a name for themselves in the oil patch.

He quickly moved through the ranks and ultimately landed as the company's Division Land Manager, managing the company's Gulf Coast, Rockies, and Canadian assets until 1999.

A certified professional landman since 1995, Carl has been an active member of AAPL, the Canadian Association of Petroleum Landmen, the Houston Association of Professional Landmen, the Independent Petroleum Association of America and the Texas Oil and Gas Association.

Carl was elected and has held multiple positions with the HAPL, including President. For AAPL he has served multiple terms on the Executive Committee including First and Second Vice President. He has also served and chaired multiple AAPL and NAPE committees that have shaped AAPL and NAPE as we know them today.

Carl has been named Landman of the Year for both HAPL and AAPL and still makes the time to give back to his alma mater as a member of the advisory board for the AAPL Accredited Energy Management Program at OU.

He lives in Houston with wife Jennifer and daughter Victoria and is an active member of the First Presbyterian Church.

Ellarie Sutton, was born and raised in Northern California and got to Texas as quickly as she could. After graduating high school in California, she attended Texas Tech University and sought out the AAPL Accredited Energy Commerce Program. Her ultimate graduation included a minor in Finance. Shortly after graduation she joined EOG Resources as a Landman in their Fort Worth office. Recently she transferred to their Midland office and is working some of their New Mexico assets. Ellarie was selected as AAPL's Outstanding Graduate for the year 2021.

Brian Tolson, is a partner and senior landman for Equitas Energy Partners based in the Dallas-Fort Worth area.

He grew up in the small town of Aledo, Texas and went on to graduate from Texas Tech University in 2007. After working for a few years in the real estate industry, he eventually found his calling as a Field Landman. He has worked in several major basins across the country and continually welcomes the challenges of learning all the energy industry has to offer.

After joining AAPL in 2012 he began working towards certification and ultimately earned his CPL in 2021. He is a member of both the Dallas and Fort Worth local landman associations. In addition to serving in multiple roles with DAPL, including President, he is the DAPL AAPL Director and DAPL Scholarship Committee Co-Chair. He is also serving his second term on the AAPL Field Landman Seminar Committee and was recently nominated to serve as Secretary for AAPL next year on the Executive Committee.

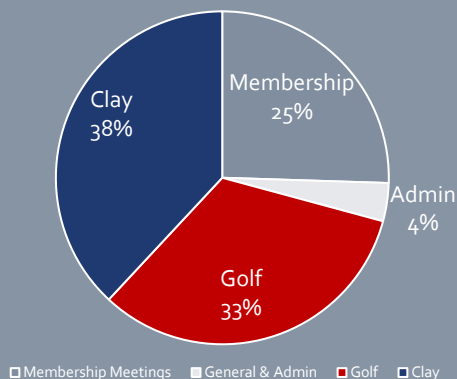

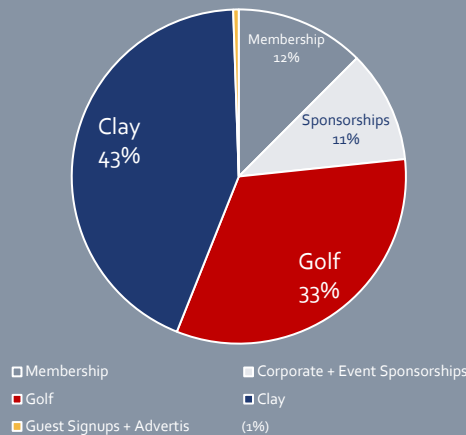


Approved DAPL Budget 2023-2024 (Balanced Budget)
