SLIDE

Moving forward, I would like to touch briefly on the 2024-2025 Budget proposed by the Budget Committee and approved by the Board this week.

- 1. We have a balanced budget at \$294,000, which is our largest budget to date
- 2. This includes an estimated \$55K earmarked to our Philanthropy Partners
- 3. This also includes our annual contribution to HAPL for its lobbyist
- 4. We are also maintaining our Membership Certification Reimbursement Program (subsidizes cost of certification for our members)
- 5. The revenue from the Golf Tournament contributes \$5K to OU and TTU scholarships annually
- 6. The Clay shoot revenue contributes \$15K to DAPL operating fund

SLIDE

This is a quick visual aid which highlights our budgeted expenses and revenue.

Under the expense pie chart, you'll note 67% of our annual expenses come from the Golf and Clay Tournaments with regular membership events comprising only 27% of costs.

Under the revenue pie chart, you'll note 75% of our annual revenue comes from Golf and Clay with membership dues comprising around 13% of our total gross expense.

It's certainly taken some work (and restraint) by our budgeting committee, but I am happy to report we are balanced and are positioned well for the upcoming year.

- We are also in the planning stages for a November Educational Institute which will be paired with a Pickleball Tournament hosted by NAPE Charities Fund. Be on the lookout for more details regarding that event in the coming months.

I also wanted to give an update on the 2023 Brad Bradley Memorial Scholarship Fund organized by the Landman Scholarship Trust.

We received \$1,532.59 from members with a \$1,000 DAPL matching donation. This totaled \$2,532.59 in funds donated to LST in Brad's memory.

Thank you all for your participation in remembering Brad, whom we all miss dearly.

We also wanted to highlight the Charitable Donations made to our Philanthropy Partners, Treasured Vessels Foundation and the Texas Scottish Rite Children's Hospital.

In July of 2023, in partnership with the Annual Clay Shoot and its sponsors, DAPL was able to raise \$35,000 for Treasured Vessels and its mission to rehabilitate trafficked women in the Dallas metroplex.

In February of this year, in partnership with the Annual Golf Tournament and its sponsors, DAPL was able to raise \$20,000 for the Texas Scottish Rite Children's Hospital. This most recent donation has helped DAPL eclipse \$450K in total funds donated to the Scottish Rite Hospital and its efforts to treat mobility issues in youth across the country.




