

Sean Fletcher billed Campbell Development, LLC a FULL day on Friday, May 17, 2019 for a project located in Pennsylvania, as is evidenced by his 5/31 RHL 74 invoice.

On the weekend of September Saturday 1- Monday 3, 2018, Sean Fletcher attended the Nazarene National Softball Tournament in Springdale, Ohio.

This is evidenced by a post on Sunday Sept 2nd (Above) in which Sean Fletcher posts a photo of himself with the caption "Play Ball, Day 2."

He then appears in a video, introducing himself as a member of the team (left)


Additionally, in a post made by a fellow player on Monday, September 3rd (left), Rob Propheter notes [summarized] that it was a tough weekend and that they were defeated by the team "Sandusky." According to the bracket published on the Nazarene National Softball Tournament Website, this match up would have occurred on Monday, September 3rd, 2018 at 2PM.

Sean Fletcher billed Campbell Development, LLC a FULL day on Monday, September 3rd, 2018 as is evidenced by his 9/15 SHR 35 invoice.

Please see the upper left hand screenshot for a video of the trip back to Kentucky on Monday, September 3rd, 2018. In which his son (Brenden Fletcher, who also played on the team and is in the team photos) is videoed by Sean Fletcher. These are LIVE videos. These videos take place in the real time they are posted.

Sean Fletcher billed a full day to Campbell Development, LLC during a day when he was traveling with his son and playing in a softball tournament.






In this post, which occurs at 10:14am on Friday August 3, 2018, the Sean Fletcher is at the pool with the caption "Pool day! Where you at Greg A Blake"

Greg A Blake's facebook page shows he lives in Padacah, KY

Note Sean Fletcher's comment "I'm sure in WV they swim with clothes on but not here in KY, LOL. Thing is in full effect!!"

On August 3, 2018, Sean Fletcher billed a FULL day and 128 miles to Campbell Development, LLC for the following "Stopped by Gresko's house to get a tax form 3 attempts Stopped by Scott Campbells to discuss the lease," as evidenced by his RHL 71 8-15 Invoice. Sean Fletcher also billed a FULL day to Campbell Development, LLC on August, 4th, as well as 104 miles for "Stopped by Michael Gresko to get a W-9 and PA tax form. Called and emailed Sheri Everates for the ratification." Scott Campbell and Michael Gresko live in Pennsylvania.

It is evident that Sean Fletcher was in Kentucky this weekend and that he fraudulently billed for time he did not incur and efforts he did not perform.


In this post, which occurs at 2:18PM on a Tuesday, the Plaintiff is at what appears to be a sports bar. He is wearing what appears to be a cutoff or sleeveless t-shirt and ball cap.

The caption reads "A rose between two idiots."

As evidenced by the Plaintiff's RHL 99 10-31 Invoice, on Tuesday, October 22, 2019, Sean Fletcher billed a **FULL** day and 121 miles to Campbell Development, LLC for driving to "Union Town PA" and for the purposes of visiting the following people:

In this post, dated Oct 5 at 4:17PM, Sean Fletcher makes a series of posts about being on Michael Duke's boat, which Sean Fletcher were known to utilize frequently on weekends.

Take special notice of Sean Fletcher's comments, in which he takes a photo of his hand being passed a beer by Mike Duke.

Sean Fletcher billed a **FULL** day on October 5, 2019, as evidenced by his Oct 15th RHL 71 Invoice. He also billed 147 miles for "[Driving] to Turtle Creek PA."

Sean Fletcher is on the boat no later than 4:17PM.









On August 29th, 2018 at 4:05PM, Sean Fletcher made a **LIVE** post with what is presumably his granddaughter.

He is in Orlando, Florida at this time.

Sean Fletcher billed Campbell Development, LLC a FULL day on Aug 29th for work on the RHL 31 project, as evidenced by his 8/31/2018 Invoice.

On August 29th, 2018 at 1:21PM, Sean Fletcher made a post with what is presumably his granddaughter.

He is in Orlando, Florida at this time.

Sean Fletcher billed Campbell Development, LLC a FULL day on Aug 29th for work on the RHL 31 project, as evidenced by his 8/31/2018 Invoice.

On August 28th, 2018 at 1:21PM, Sean Fletcher made a post announcing the birth of what is presumably his granddaughter.

He is in Orlando, Florida at this time.


Sean Fletcher billed Campbell Development, LLC a FULL day on Aug 28th for work on the RHL 8 project, as evidenced by his 8/31/2018 Invoice.


Sean Fletcher billed Campbell Development, LLC 175 miles for "[Driving] to Parkersburg WV" on this day. How is it that Sean Fletcher could make these charges when he was in Orlando, Florida? Which is 863 miles (12 hours and 51 min) from Parkersburg.

On August 27th, 2018 at 6:27PM, Sean Fletcher posted that he was on his way to Orlando, it appears to be for the birth of his granddaughter.

The caption reads "Headed to Orlando. Daughter's baby is due anytime. stay tuned!!"

Sean Fletcher billed Campbell Development, LLC a FULL day on Aug 27th for work on the RHL 8 project, as evidenced by his 8/31/2018 Invoice.





On 10/18/2018 Sean Fletcher posted that he had checked in to the Carnival Triumph Cruise Ship in New Orleans, LA.

According to the Carnival Triumph Cruise Ship official itinerary for 2018, this ship departed on 10/18/2018 from New Orleans LA and returned on 10/22/2018.

In Sean Fletcher's comments on a post dated October 17th, he responds to a facebook friend with the following:


"Shawn Rine I'll be back after the 24th. We'll plan!!"

Shawn Rine's facebook page appears to show that he lives in Canton, Ohio.

Sean Fletcher billed Campbell Development, LLC a FULL day on Oct 23, 2018 as evidenced by his 10-31 RHL 71 Invoice.

Sean Fletcher billed Campbell Development, LLC a FULL day on Oct 24, 2018 as evidenced by his 10-31 RHL 71 Invoice. He also billed 90 miles for "[Driving] to Pittsburgh PA and Waynesburgh PA" His invoice notes that on this day he "Met and Singed [SIC] the Ryerson Ch. Drove to the office and picked up the lease and checks."

There is no evidence Sean Fletcher obtained this lease. The lease he billed for was notarized and submitted by a different contractor, Mike Duke.




In this example, dated September 17, 2019 at 11:56AM Sean Fletcher makes a post with the following caption:

"Need someone to clean my house. Anyone know someone in the paducah [Kentucky] area that does that?

Further down, in the comments, someone asks him "Where u located at." to which he responds "In Paducah ky."

Sean Fletcher billed a **FULL** day on Tuesday, September 17th, 2019, INCLUDING 118 miles for "[Driving] to Claysville and Bridgeville PA. and Bentleyville PA," as evidenced by his 9-30 WFN 11 Invoice.

If Sean Fletcher is in Kentucky at 11:56AM, which is over 9 hours and 600 miles away, one must ask how he could have driven 118 miles in PA? The answer is, he couldn't have.



The 18th of August, 2019 was a Sunday.
This post is included to provide further
evidence that Sean Fletcher was on
vacation during this time.

Sean Fletcher did not bill for this day.



The 19th of August, 2019 was a Monday.

Sean Fletcher billed for a FULL day of work on August 19th, 2019, as is evidenced by his RHL 71 8-31 invoice.

Yet, it appears the Plaintiff was actually sunning himself on the beach this day.
