







EPA Finalizes Stricter Methane Rules For Oil And Gas Sector By Keith Goldberg Law360

(December 2, 2023, 3:02 AM EST)

The U.S. Environmental Protection Agency on Saturday finalized sweeping methane emissions control requirements for oil and gas infrastructure that include the first-ever requirements for existing sources. Formally unveiled at the United Nations climate change conference in Dubai, United Arab Emirates, the final rule is the culmination of a two-plus-year rulemaking process that is a key prong of the Biden administration's efforts to clamp down on methane emissions. The final rule creates a comprehensive scheme to reduce methane and volatile organic compounds pollution, covering existing oil and gas sources and additional categories of new oil and gas sources; increasing monitoring to identify "super-emitters" for prompt





mitigation; and strengthening requirements for flares to ensure they are properly operated. The EPA originally proposed the rule in November 2021, then issued a supplemental proposal in November 2022 that was built off more than 470,000 public comments on the original proposal. "We've crafted these technology standards to advance American innovation and account for the industry's leadership in accelerating methane technology," EPA Administrator Michael Regan said in a statement Saturday. "Thanks to robust public feedback and engagement with states, tribes, companies, and organizations, we are finalizing this historic action to reduce climate pollution, protecting people and the planet." The EPA said the final rule will prevent the emission of approximately 58 million tons of methane between 2024 and 2038, the equivalent of 1.5 billion metric tons of carbon dioxide, which is greater than was projected in the 2021 and 2022 proposals. The final rule will also prevent emissions of 16

million tons of volatile organic compounds, or VOCs, and 590,000 tons of toxic air pollutants such as benzene between 2024 and 2038, the EPA said. Agency officials said the largest chunk of additional emissions reductions in the final rule comes from a directive for new oil wells to eliminate routine gas flaring — a requirement that is phased in over two years — as well as requiring continuous operation of flares on storage tanks. The final rule requires companies to comprehensively monitor and plug methane leaks from well sites and gas compressor stations, while giving them the flexibility to use different detection technologies, such as aerial monitoring. It also establishes emissions standards for new and existing equipment process controllers, as well as zero-emissions standards for pneumatic pumps, though the EPA said there is compliance flexibility baked in. Under the "super-emitter" program, the EPA said it will approve qualified third-party companies to identify large methane releases or leaks.





The agency will then validate the information sent by those third-party companies, then notify the responsible oil and gas companies to take action. States will be responsible for crafting and submitting plans for existing oil and gas sources to comply with the final rule, and those plans are due two years from the rule's effective date. EPA officials said the rule provides guidance regarding deadlines and how states can tailor their plans to state-specific issues and any existing methane control programs. Methane, a short-lived but powerful greenhouse gas, has been the subject of increasing regulation over the past decade. The Biden administration has made finding new ways to crack down on emissions a priority, and while past rules have applied to new and modified oil and gas sources, existing sources are by far the largest contributor in the sector. "From mobilizing billions in investment to plug orphaned wells, patch leaky pipes, and reclaim abandoned mines to setting strong standards that will cut pollution from the oil and gas sector,

the Biden-Harris administration is putting the full throw-weight of the federal government into slashing harmful methane pollution," Ali Zaidi, President Joe Biden's national climate adviser, said in a statement Saturday. At least one major oil and gas company is on board with the EPA's final rule: BP PLC. "We appreciate the collaborative way EPA, NGOs and industry worked together on this rulemaking," BP Americas chairman and president Orlando Alvarez said in a statement provided by the EPA on Saturday. "We congratulate the administration on this important milestone and look forward to working together on the next phases of implementation." The Environmental Defense Fund, which has consistently pushed for tougher methane regulations for the oil and gas industry, also praised the final rule. "EPA's limits on oil and gas methane



SEC's Climate Proposal Leads Rules Lined Up For 2024 Votes By Tom Zanki Law360

(December 6, 2023, 8:33 PM EST)

The U.S. Securities and Exchange Commission on Wednesday outlined its regulatory priorities for 2024, revealing that a long-awaited vote on climate disclosures could happen by April, alongside



many new proposals that may be unveiled next year. The securities watchdog's agenda, filed with the federal Office of Management and Budget, contains a robust plate of 43 items, including 29 matters that could be finalized by spring and 14 potentially new proposals. The SEC and other regulators update their short-term priorities semiannually with the White House, though such agendas are not binding. "We're updating our rules to promote the efficiency, integrity, and resiliency of the markets," SEC Chair Gary Gensler said in a statement Wednesday. "We do so with an eye toward investors and issuers alike, to ensure the markets work for them and not the other way around." The Commodity Futures Trading Commission, the SEC's sister agency that oversees derivatives, updated its agenda as well. The CFTC listed 26 proposals that are at various stages. Notably, the SEC's agenda lists an expected vote on its controversial climatedisclosure rules by April. A divided SEC in March

2022 proposed that public companies bolster their climate-related disclosures on grounds that more investors are factoring environmental impact in their decisions and would benefit from robust information. Critics of the SEC's 510-page rule say it is costly and would burden companies by requiring them to report emissions caused by third parties in their supply chain. The SEC received more than 15.000 comment letters on the contested rule from backers and opponents. Before taking a final vote, the SEC often revises proposals based on public feedback. The SEC also expects final votes regarding new rules governing: the use of predictive data analytics and other artificial intelligence by brokerage firms; special-purpose acquisition companies; shareholder-voting proposals; how investment advisers safeguard client assets; as well as ESG





— or environmental, social and governance and cybersecurity disclosures by investment advisers. The agency is targeting April 2024 for final votes on these and other items, but schedules can change, if the votes happen at all. The SEC's agenda also lists potential new proposals, including rules that could tighten the "accredited investor" definition, which determines who is eligible to invest in private securities. The SEC also may propose additional disclosure requirements of private startups and revise how "shareholders of record" are counted at private companies. Additionally, the SEC may propose that public companies bolster disclosures about "human capital," meaning workforce demographics, and seek to require that public companies provide more information about the diversity of their boards of directors. The SEC could also propose new rules regarding what securities exchanges are eligible for an exemption from registration under Regulation

ATS, or alternative trading systems, plus rules governing the resale of restricted securities under Rule 144. Certain SEC items, including accredited-investor and human-capital proposals, are tentatively scheduled for April, while the corporate board diversity proposal could be unveiled next October. The CFTC may vote on seven proposals between December and May, including a plan that would amend regulations governing uncleared swaps for swap dealers and major swap participants for which there is not a prudential regulator, as well a proposal that would oversee the recovery and winddown plans for derivative clearing organizations. The commodities watchdog also lists 16 new proposals, including a plan that would require future commissions merchants and swap market participants to improve information security and other safeguards, scheduled for introduction on Dec. 13. Both the SEC and CFTC are governed by five-member committees, of which three are Democrats, reflecting the party of President Joe Biden. The political makeup of the agencies could shift after the 2024 presidential election, potentially altering regulatory priorities. -- Editing by Linda Voorhis.

Questions from the Field



Q: On January 1, A, an individual, the owner of no mineral interest in the NW/4, executed a Warranty Deed form conveying "...all of Grantors interest in the NW/4," to LLL Corp.

On February 1, AAA, Inc., a company that is solely owned by A acquires a mineral interest in the NW/4.

On March 1, A, individually, executes a Quit Claim Deed of the NW/4 to XYZ Corporation.

Who owns the mineral interest in question in the NW/4. - S.M.

A: A can't claim that he owns the mineral interest because A was never conveyed an interest at any time. Further, any interest he would have owned was deeded to XYZ.

LLL Corp. will claim that it owns the property by virtue of the warranty clause in the Deed from A. LLL Corp. would assert that although A did not own the property as of January 1, it did acquire the interest in corporate form as of February 1, and that by after-acquired title, its interest became vested in LLC Corp.

AAA will claim it owns the interest, because it acquired the interest, but never conveyed an interest.

XYZ Corp. will claim it owned the NW/4, because although A did not own it individually, A intended to convey some interest at the time of the execution of the Deed on March 1.

There are two issues involved. The first issue is whether the doctrine of after-acquired title under the January 1 Warranty Deed vests any interest in LLL Corp. Under a Warranty Deed, in the event that the Grantor does not own all the interest at the time of a conveyance, but warrants that he owns the NW/4, for example, any interest subsequently acquired by the Grantor would immediately vest in the Grantee under the Warranty Deed.

However, a Deed that describes the premises but prior to the description of the premises, conveys "all my right, title, and interest" then the warranty clause cannot be used to enlarge the conveyed estate to include after-acquired title. In other words, the deed only conveys what the Grantor owned at the time. Because the January 1 Warranty Deed recites that it only conveys the right, title, and interest of the Grantor at the time, it does not warrant the title to all of the mineral interest in the NW/4, but only warrants all right, title, and interest owned by the Grantor on January 1. It is said to be more equivalent to a Quit Claim Deed than a Warranty Deed. Reed v. Whitney (OK 1945). The warranty clause would not kick in so as to allow LLL Corp. to receive an interest because in this situation the deed in question was not legally a Warranty Deed. Further, A was never conveyed any interest.

The second issue is estoppel.

AAA would be estopped to deny the validity of the Deed executed by A on March 1. Although it was executed by the wrong entity, Aobviously meant to execute a Deed conveying something to XYZ Corporation. Estoppel by Deed is a bar which precludes one party to a Deed from asserting against another party any right or title in derogation of the deed or from denying the truth of any material facts inserted therein. Equitable Royalty Corp. v. Hullet (OK 1952). AAA would be estopped to deny the validity of the deed executed by its principal, A.

Therefore, although it is difficult to know what a court would do, my initial inclination would be to place XYZ into title by virtue of the fact that A had executed the Deed to them. Of course, the interest is not marketable and would be subject to requirements.

Now, it could be argued that the same estoppel should allow LLL Corp. to obtain title to the interest. However, at the time of the conveyance to LLL Corp., neither A nor AAA owned any interest.

In the event of litigation, certain facts could come out, which could change a court's ruling. For example, if it was determined that XYZ was knowledgeable that A was coming into title by virtue of an inheritance or conveyance from a specified party and that they were aware that although A had not received the interest, they still purported to convey that particular interest to LLL Corp., then XYZ could be on actual notice that the acquired interest was, in fact, conveyed.
