I was able to attend the last AAPL Quarterly Director's and Annual Meeting in Pittsburgh, PA. If you have never been and get the opportunity to go, I highly recommend it.

The board meeting started with AAPL's financials that were present by Treasurer Michael Pisciotte. He reported that as of March 31, 2019: AAPL, Inc. had total assets of \$35,427,836; AAPL Educational Foundation, Inc. had total assets of \$4,261,865; and the AAPL Landman Scholarship Trust had total assets of \$7.505.592; so that the combined total assets of all three entities is \$47,195,293. AAPL's Executive Vice President was up next. Melanie Bell indicated that AAPL welcomed 1,296 new members and has a total membership of 16,384, AAPL has provided Ohio Certificate of Good Standing to 187 AAPL's members to comply with Ohio's new registration, and NAPE's net income has exceeded the prior two years. Then Melanie provided the board with her big announcement that she will be retiring at the end of the year. Melanie has served AAPL with dignity and at a high level and will be missed. A task force will be formed to hire her successor. President Mike Curry was up next. He covered his presidential travels, and then he got into the business items. First, the resignation of the Black Warrior Association of Professional Landmen, located in Birmingham, Alabama, was accepted by AAPL. With the recent merger of Energen Resources Corporation and Diamondback Energy, the Energen office in Birmingham closed and the Black Warrior

Association lost almost all of their members.

Next, Chuck Walter, Secretary, presented the
2019-2020 elections results (with roughly 15% of
the membership voting) and the new AAPL officers
are as follows:

The last major business item was the Education Committee being split into three separate new committees. With education being the backbone of AAPL and the workload this committee was doing, this was a wise decision.

The next day the Annual Meeting got underway with 796 in attendance. The attached proposed change to the AAPL Bylaws was unanimously approved during the Business Luncheon. The remainder of the annual meeting was filled with quality speakers, educational seminars, and networking events.

Some of you may have noticed that AAPL has a new logo and website. The website is a definite upgrade! It has an updated look and feel, is easier to navigate, and allows for more information to be shared with the public. Here is the new logo:

#### **OHWM**

The Board of University of School Lands entered into a 12 month contract on May 28 with KU to complete a \$1,088,635.00 contract to define acreage adjustments. The Board wants the KLJ information so it can accurately determine royalty and bonus refunds to the operators and lessees.

### **August Auction**

The Board of University and School Lands will conduct an online oil and gas lease auction for six hundred and ninety four (694) tracts in Billings, Bowman, Dunn, Golden Valley, McKenzie, Mountrail and Ward Counties, ND. Bidding will commence July 30, 2019 at 9:00 a.m. CST and ends August 7, 2019.
