

I am extremely honored to write a nomination letter on behalf of PLM Director and Associate Lecturer, Mr. Kristopher Koski for PLM Director of the Year with AAPL. Mr. Kris is a gifted Director and faculty member at the University of Wyoming. He has consistently impressed me with his talents in and out of the classroom. It is evident he has impressed students as well, as Kris has some of the highest teaching evaluations I have ever had the pleasure of reading. In this letter, I would like to describe this talented Director to you. In the fall of 2020, Mr. Koski took over as the Director of the Professional Land Management (PLM) program within the School of Energy Resources at the University of Wyoming. He also serves as an Associate Lecturer in the PLM program teaching various courses since the fall of 2017. In addition to these roles, Mr. Koski is Of Counsel at Long Reimer Winegar LLP, where he maintains an active oil, gas, carbon storage, renewables and land title, transactional, litigation and regulatory practice. In his practice, Mr. Koski regularly appears before the Wyoming Oil and Gas Conservation Commission and the State and Federal Courts of Wyoming. He recently argued in front of the Wyoming Supreme Court and prevailed in a foundational case pertaining to eminent domain in the State of Wyoming. Prior to joining UW, Mr. Koski served as an attorney with two private law firms where he maintained an oil and gas law and land practice. Mr. Koski was an associate at a Houston, Texas based law firm where he represented oil and gas operators in the drafting and production of Drilling and Division Order Title Opinions. While in law school, Mr. Koski was a student intern for the University of Wyoming Legal Services where he assisted indigent clients in family law and various other civil law matters. He was also a student intern for the University of Wyoming School of Environment and Natural Resources where he provided water law research and drafted related legal memoranda. Prior to his law career, Mr. Koski was an electrical engineering intern at Xcel Energy where he worked on various electric power distribution projects. This mix of the legal as well as the technical side of the energy industry provides Mr. Koski with a unique understanding of the challenges associated with energy production and utilization.

Mr. Koski is licensed to practice law in the States of Wyoming and Colorado and is active in the Wyoming Association of Professional Landmen and the Rocky Mountain Mineral Law Foundation. Mr. Koski is currently serving as a member of the Ethics Committee for WAPL. Mr. Koski holds a bachelor's degree in engineering from the Colorado School of Mines '05 and a Juris Doctorate from the University of Wyoming College Of Law '08, where he was top of his law class.

Mr. Koski focuses his legal practice primarily in the oil, gas, and natural resource areas of the law. He maintains a diverse practice representing a wide variety of energy companies and landowners in title, transactional, regulatory and litigation matters. Mr. Koski regularly speaks on various topics to groups such as the Rocky Mountain Mineral Law Foundation, the Wyoming Association of Professional Landmen, the State Bar of Wyoming Natural Resources Section and the National Business Institute.

It is my pleasure to provide this letter in support of Kris Koski for the 2023 AAPL Accredited Program Director of the Year Award. Professor Koski is the Director of the University of Wyoming, School of Energy Resources, Professional Land Management Program.

In addition to serving as Director for our program, Professor Koski is licensed, practicing attorney. His real-world expertise benefit our students as he teaches them with his exceptional instructional approach, which is highly engaging and effective in aiding the interdisciplinary student population enrolled in his classes. Professor Koski's classes are often students' first exposure to legal concepts and a law school approach to instruction. Being a practicing Wyoming attorney and having graduated first in his class from the UW College of Law, he is well suited and experienced with this style of instruction, which requires interaction of students by calling on them to answer questions throughout the instruction. Experiencing his unique approach is often mentioned as a high point for many SER students as evidenced in the letters of support provided by both current and former students.

Professor Koski is fully dedicated to the success of his students, both inside and outside the classroom. He connects students with potential employers by arranging networking opportunities — even going the extra mile to arrange transportation. Professor Koski also is committed to experiential learning and offering meaningful experiences for his students. For example, in 2019 Professor Koski developed a service-learning project during which students identified Cheyenne neighborhoods with racially restrictive covenants in their deeds and worked with homeowners to remove the covenants. The project included using assessor records to identify homeowners, conducting searches through the Laramie County Clerk's office, drafting letters and a trip to Cheyenne to meet with homeowners in person. This project was tied directly to course learning objectives and allowed students to improve communication and research skills across digital and in person modalities. Needless to say, this innovative and touching assignment deeply impacted the students.

Without Professor Koski, the School of Energy Resources would not be able to deliver our curriculum and our students would certainly not find a more dedicated, caring, humble instructor elsewhere.

It is my honor to support Kris Koski's nomination and candidacy for the AAPL Accredited Program Director of the Year. Kris took over from me as the director of the program in 2020 at the onset of the COVID-19 crisis. He not only stewarded the program through the pandemic and the numerous changes in education during that period, but has also strengthened our industry partnerships, expanded our curricular offerings and partnerships with other academic units, and grew our enrollment. Kris is a well-recognized leader in the spaces of energy law and land management in Wyoming and nationwide.

The PLM academic program at UW has thrived under Professor Koski's leadership. Kris has worked with our new academic director and admissions team to grow the percentage of women in the PLM program. Enrollment by female students has grown by 50% since 2020. Kris has also expanded our curricular offerings, including through development of a minor in Energy Resource Management, a certificate in CCUS, and a 3+3 program with the College of Law. As part of these new offerings, Kris has helped expand our curriculum to cover additional topics related to the transformation of the energy industry including renewables, transmission, decarbonization pipelines, and hydrogen. Next year the program will include the first-ever course on nuclear energy project development. These new programs and courses will help to expand the reach of land and energy education on campus and have the potential to bring a greater number of students into the profession.

Kris is an ambassador for the AAPL program and the land profession with industry. Last year he organized the inaugural Rocky Mountain Professional Landman Conference. It had more than 90 attendees and provided an excellent opportunity for students and industry to connect. The conference will be held again in May of 2023.

Dear members of the AAPL Accreditation Committee,

It is with much enthusiasm that I recommend Kris Koski for the AAPL Accredited Program Director of the Year Award. Through my previous experience as a student in his courses, and a current member of the University of Wyoming's Professional Land Management ("PLM") Industry Advisory Board, I can attest Mr. Koski is an enthusiastic educator, engaged supporter, and strategic leader deserving of this recognition.

Professor Koski serves not only as the Director of UW's program but also as an exuberant educator with a contagious passion for the law courses he teaches. He shares his passion with all of his students and deliberately seeks out those topics that pique each one's interests; inviting each of them to become excited about each subject he teaches. For example, he was able to take the objectively boring legal topic of the Rule Against Perpetuities and stimulate a classroom of students to the point where their Friday night party conversation was about how, "no interest is good unless it must vest, if at all, no later than twenty-one years after some life in being at the creation..."; no small feat! A small testament to how Professor Koski's authentic passion for the law can ignite the flame of curiosity in his students.

Remarkably, Mr. Koski's unwavering passion for the subjects he teaches and relentless desire to develop the students in the UW PLM program inspires them to apply their classroom knowledge to real-world problems. One example, was the development of a project to rid several cities in Wyoming of racially prejudicial covenants. Through the education in his Property Law courses, and through his passionate support of the project as a sponsor for the student organization, his students began a process of identifying and eradicating racially prejudicial covenants on title property records in Cheyenne and Laramie. Professor Koski's comprehensive classroom education equipped his students with the capabilities to address this problem while his clear passion for the law and community development inspired the students to leverage their capabilities to better the community. Here he illustrated the breadth of application for a Land Professional and embodied AAPL's strong Code of Ethics; establishing material community goodwill. Notably, Professor Koski acted with humility when this project received positive press and resulted in a codified law for expedited removal of racially prejudicial covenants; crediting his students for the entirety of the work despite his heavy involvement and support.

Through his leadership, the program is now structured to enable students to receive a broader education in energy and realize a greater capacity to overcome the challenges of the future. Previously fossil-fuel centric courses have been broadened to unveil the full energy spectrum, the curriculum is more adaptable allowing for multiple new minors and an accelerated path to a Juris Doctorate, and extracurricular events such as the Rocky Mountain Landman Conference now offer greater exposure to the extent of roles land professionals occupy. Mr. Koski's strategic stewardship is progressing the capabilities of, and opportunities for, land professionals and is resulting in impactful outcomes for students.

Kris Koski is a truly remarkable Director with a sincere, humble passion for the development of the students in the Professional Land Management at the University of Wyoming.
