MOTION TO CHANGE CPL

MARCH VOTE COULD CHANGE DEGREE REQUIREMENT TO SIT FOR EXAM

By far, the hottest topic at the first quarterly AAPL board meeting in Cleveland, Ohio was the motion to change the educational requirement to sit for the CPL Exam.

As I announced at the HAPL November Luncheon, a motion was made and seconded to create a second option for members to sit for the CPL exam which would require 15 years of experience in lieu of the requirement for a bachelor's degree.

For many years, the prerequisites to sit for the CPL exam included the requirement that one have a bachelor's degree from a regionally accredited university or college, but that could all change depending on which way the vote goes in Oklahoma City.

The AAPL Board of Directors is made up "of elected officers, the

Immediate Past President, and one (1) director from each affiliated local association except Canada, which shall be allowed two (2) directors." [AAPL Bylaws ARTICLE XI Section 1.] Currently, there are 41 Directors, six (6) elected officers, and an Immediate Past President, for a total of 48 voting members.

"The terms of the Voluntary Certification Program shall be set or amended by a two-thirds (2/3) majority vote of those directors present at a meeting of the Board of Directors." [AAPL Bylaws ARTICLE VI Section 1.] *
