Dear Mr. Yost:

This letter is for the purpose of formally nominating Russell Shinevar for the AAPL Annual Landman of the Year Award. After reviewing the criteria used to judge both the Lifetime Achievement and Landman of the Year Awards, I am confident that he would be an outstanding candidate for either award. I am approaching my 14th year in the Petroleum Land Management profession, which I have built almost entirely in the State of Michigan. My success and continued progress would never have been possible without the guidance and mentorship I have been generously awarded by Russell. I have worked closely with him on several projects and I have always been able to rely on him for advice and mentorship even when I've worked on projects independently around our State.

I began working as a Landman in 2007 for a broker out of Traverse City, Michigan. I had no previous experience in the field and was given the opportunity because I had earned a Bachelor's Degree and was referred by my brother, who had been working as a Landman since 2006. On the advice of the broker I was hired by, I decided to join the Michigan Association of Professional Landmen (MAPL) for the purposes of networking and broadening my knowledge of the industry. At the time, Russell was the Vice President of MAPL and I remember hearing him speak, engage and ask questions at every meeting I attended. I was always impressed by his inherent leadership abilities, knowledge of the industry and ability to explain information, even to those of us who had little experience and/or education in the business.

Russell became president of the MAPL in 2008 right around the time oil prices began to approach \$100/Barrell. As the industry flourished throughout the country, oil and gas exploration in Michigan was developing suddenly developing rapidly and there was no shortage of land work. I began attending MAPL meetings regularly and it wasn't long before Russell took notice. He encouraged me to join AAPL and work on attaining certifications and furthering my education in the process. I took his advice, joined AAPL and began attending every MAPL and AAPL meeting that took place in my home state.

In 2009, I relocated to the Lansing, Michigan area so my wife could accept a job opportunity as she began her career as a Registered Nurse. Being an Independent Landman who worked primarily on the road or from my home office, Lansing was a favorable location because of its proximity to most of the active oil and gas projects in the state. However, it was extremely difficult for me to leave my home and move to a city where I had no friends, family or colleagues, except for Russell. Over the next few years, I was able to attain my RL, RPL and eventually my CPL. Russell continued to reach out to me, offer help, advice and ultimately mentorship.

As the years progressed, I had the invaluable opportunity to work together with Russell on various projects. He acquainted me with functions of land work I had no experience with and almost single-handedly, he facilitated the development of my career as a landman. When our projects together would wind down, he helped me network and provided referrals in order for me to continue working full-time as a landman. We spent time together working on marketing and coming up with creative ways to advertise our expertise and offer our services to brokers throughout the State of Michigan. Being independent Landmen comes with its benefits, but it also requires extra diligence and ingenuity in order to be sustainable.

Russell has been an extremely important part of my development as a Landman. When oil prices plummeted in 2015, he was always someone I could rely on for guidance and assistance. Work slowed down, but we still spent time together brainstorming ways to keep ourselves busy. I became very familiar with Russell's extensive involvement in the industry, not only as a mentor to myself and others, but also as a volunteer and member of various AAPL committees. His has always displayed an unwavering work ethic, unparalleled authenticity, and professionalism in our work together. I have also been constantly inspired and motivated by his myriad of individual achievements and generous volunteer efforts as an advocate, supporter and champion of the Oil and Gas Industry in Michigan and throughout the country. In my near 13 years of work as a Landman, I have not met another person that even compares to the contributions Russell Shinevar has made to the industry and the community of professionals it supports. In my professional opinion, there is no better candidate for the AAPL Landman of the Year Award.
